International Law and Korean Security

February 26-27, 2019 U.S. Naval War College, Newport, Rhode Island

North Korea poses perhaps the greatest threat in the most important part of the world, and international law is the language of diplomacy for maintaining regional peace and security. The Stockton Center for International Law (SCIL) and Korea Institute of Ocean Science and Technology (KIOST) joined by Development of International Law in Asia-Korea (DILA-KOREA) and Korea Maritime Institute (KMI) have combined efforts to explore the various dimensions of Korean security, including proliferation of weapons of mass destruction, trilateral and multilateral diplomacy, international humanitarian law and human rights, law of the sea and United Nations sanctions.

The conference is one of a continuing series of high-level expert meetings to bring together experts from international academia and think tanks, the armed forces and other government agencies and international and non-governmental organizations to consider the role of international law on the Korean Peninsula, and to shape approaches to international law and policy. The program is conducted under the Chatham House Rule to facilitate the free exchange of ideas in a dialogue format that

permits greater spontaneous interaction. Selected contributions will be published as full-length articles in *International Law Studies* (ILS). Published since 1895, ILS is the oldest international law journal in the United States.

The conference is comprised of eight panels, plus two working luncheons and one working dinner for speaking participants. Each session is composed of three or four speakers, although the emphasis is less on prepared remarks and more focused on spontaneous interaction and thoughts. Attire for the conference is military service khaki or equivalent and civilian business attire.
